Dear Marcio,

Thank you for your reply and your commitment to share answers to the broader issues and questions we raised, ahead of the launch of our publication.

On your questions 1 and 2, we expect JBS to confirm or deny receipt of animals from the direct suppliers we have identified; and JBS to confirm or deny that animals from the indirect suppliers we have identified could have entered the supply chain, during 2018 and/or 2019. We also ask you to indicate the most recent date on which you have sourced cattle from these suppliers.

On your question 3, regarding Fazenda Bonsucesso, an online search using the words 'Bonsucesso Ivanildo incendio Pantanal' returns thousands of results, as illustrated in the screengrab below.
